1. Preamble

On March 8, 2007, the *Ontario Energy Board (OEB)* granted Newmarket Hydro Ltd. (NHL) and Tay Hydro Electric Distribution Company Inc. (THEDCI) leave to amalgamate. The merger of NHL and THEDCI was completed on May 1, 2007. The amalgamated entity formed is Newmarket-Tay Power Distribution Ltd. (NT Power).

On May 1, 2007, NT Power applied to the *OEB* for cancellation of the licences of NHL (ED-2002-0553) and THEDCI (ED-2002-0519), as well as for issuance of a new electricity distribution licence for NT Power.

On August 24, 2007 the *OEB* issued a decision and order, under file number EB-2007-0624, issuing a new electricity distribution licence to NT Power, and canceling the old licences of NHL and THEDCI. The new licence for NT Power is ED-2007-0624.

On April 4, 2008 the *OEB* issued a decision and order, under file number EB-2007-0792, amending the *service area* of NT Power and amending the licence ED-2007-0624 of NT Power.

2. Identification

NT Power is a private company, incorporated in accordance with the *Ontario Business Corporation Act.* The Town of Newmarket and the Township of Tay indirectly are the shareholders. See NT PowerCOS-500 Appendix A, Corporate Contacts for the corporate address, telephone number, and Officers.

3. Service Territory

- 1. The Town of Newmarket as of January 1, 1979;
- 2. Part of the Town of East Gwillimbury, extending from Bathurst Street in the west, to Leslie Street in the east, from the northern boundary of the Town of

Newmarket in the south, to the south side of Green Lane in the north, with the following exception:

- the area of land, being composed of Part of Lot 100, Concession 1, East of Yonge Street, more particularly described as Parts 1–13 on Reference Plan 65R-22350, also known as the Silver City Plaza;
- 3. Part of the Township of King extending from the southern boundary of Lot 34 Concession 2 in the south, to Miller Sideroad in the north, west of Bathurst Street comprised of the areas of land described as:
 - 450 meters of Lot 34 Concession 2 west of Bathurst Street
 - 150 meters of Lot 35 and the southern half of Lot 1 Concession 2 west of Bathurst Street
 - 450 meters of northern half of Lot 1Concession 2 west of Bathurst Street
 - 450 meters of Lots 2, 3, 4, and 5 Concession 2 west of Bathurst Street
- The area of Tay Township extending from the Wye River in the west to Waubaushene Channel in the east, from Georgian Bay in the north to Highway 12 in the south and including Methodist Island.
- 5. Those portions of Tay Township south of Highway 12 described as the area of all lots as they exist at the time of issuance of this Licence:
 - fronting on Highway 12 from the Wye River easterly to the east end of Trestle Road at Highway 12
 - fronting on County Road 58 southerly to the southern lot line of Part Lot 11 Concession 4.
 - on the south side of Trestle Road and fronting on Rumney Road from Highway 12 southerly to the southern lot line of Part Lot 12, Concession 4.
 - fronting on Highway 12 easterly from Vents Beach Road to Sandhill Road including all lots fronting on Frazer Lane.
 - fronting on Rosemount Road from Highway 12 southerly to the southern lot line of Part Lot 4, Concession 9 and including all lots fronting on Beckett's Side Road to Gratrix Road and all lots fronting on Connors Court.
 - fronting on Sandhill Road and Highway 12 south to the junction of Highway 12 and the Highway 400 south on ramp.

NT Power may only operate a *distribution system* within its licenced *service area* as defined in its Distributor Licence. This *service area* is subject to change with the *OEB*'s approval.

Nothing contained in this *Conditions of Service*, or in any contract for the supply of *distribution services* by NT Power, shall prejudice or affect any rights, privileges, or powers vested in NT Power by law under any Act of the Legislature of Ontario, or the Parliament of Canada, or any regulation thereunder.
